Violence against women and girls toolkit: Methods

This document briefly describes the methods used for the violence against women and girls (VAWG) toolkit, including how data was located and analysed, and how the summary estimates for the front page of the toolkit were produced.

Searching

The aim of the literature search was to identify systematic reviews or economic studies on violence against women and girls. A search strategy was designed in Ovid MEDLINE by an Information Specialist in consultation with the review team. The strategy used search terms to represent the following concepts: violence against women and girls; OECD countries; systematic reviews; and economic studies. Text word searches for terms appearing in the title, abstract or keyword fields of database records were included in the strategy alongside searches of relevant subject headings. The strategy used a geographic filter to limit papers to OECD countries and limits to English language papers. A date limit of 2013-Current was applied to the search.

The final MEDLINE strategy was adapted with relevant subject headings (controlled vocabularies) and search syntax, appropriate to each resource. The results of the databases were de-duplicated in EndNote 20. See Appendix A for full search strategies.

The following databases were searched on 3 April 2023:

- 1. MEDLINE(R) ALL (Ovid): 1946 to March 31, 2023;
- 2. Embase (Ovid): 1974 to 2023 March 31;
- 3. PsycINFO (Ovid): 1806 to March Week 4 2023;
- 4. CINAHL (EBSCO): Inception Current;
- 5. Epistemonikos (https://www.epistemonikos.org/): Inception Current.

Screening

The searches returned 4,488 records after de-duplication. Titles and abstracts were screened against the following criteria:

1. Does the study concern violence against women or girls?

Include any study focusing on violence and where the population is mostly women/girls, *or* any study of intimate partner violence, sexual violence or child sexual abuse with any population (unless exclusively focused on men/boys). *Exclude* studies which do not primarily focus on violence, even for groups at potentially higher risk of violence. *Include* reviews of mixed populations if *either* >60% of studies meet criterion *or* there is a separate synthesis on populations meeting criterion.

2. Is the study either (a) a systematic review of effectiveness, (b) a study reporting costs of an intervention, or (c) a study reporting on implementation of an intervention?

For (a), *include* any review of effectiveness reporting search strategies and inclusion criteria. *Exclude* reviews of observational data, prevalence or risk factors. For (c), *include* qualitative and/or quantitative data relating to a specific intervention.

3. Does the study focus on high-income countries, and on a setting other than policing, criminal justice or education?

Include countries classified by the World Bank as 'high income'. *Include* reviews of mixed countries/settings if *either* >60% of studies meet criterion *or* there is a separate synthesis on settings meeting criterion.

An initial sample of 10% of records was screened independently by two reviewers and differences resolved by discussion. The remaining records were screened by one reviewer alone. For full text screening, the following additional criteria were applied for systematic reviews of effectiveness (category (a) above). All full-text studies were screened independently by two reviewers and differences resolved by discussion.

- 4. Does the review contain at least two studies?
- 5. Is a full report available? (*Exclude* abstracts of conference presentations)
- 6. Does the review include primary studies? (*Exclude* reviews of reviews, but retain for reference checking)
- 7. Does the review report a meta-analysis of controlled studies?

Studies excluded on criterion (7), i.e. reviews of effectiveness without meta-analysis, were retained and coded by intervention category (see below), but generally were only included in the analysis for those intervention categories where no meta-analysis was available. We made some exclusions based on outcome or topic at a later stage: see under 'data extraction' below.

Quality assessment

We used the AMSTAR-2 tool to assess review quality (Shea et al. 2017). The tool produces an overall rating of 'high', 'moderate', 'low' or 'critically low'. Details of the results of quality assessment can be found in the technical report for each topic. Quality assessment was carried out by one reviewer and checked in detail by a second.

Data extraction

Initially, included reviews and those which did not report a meta-analysis of controlled studies (criterion 7), but which met all other criteria, were coded in broad categories of intervention and population. The codeset was developed after screening was completed and was based on the content of the included reviews. Some reviews were coded in more than one category, if they reported separate analyses of different interventions or populations; in a handful of cases we judged that the review included too wide a range of interventions to assign it to a category, and did not report separate analyses, in which case it was not included in the analysis for any topic. This coding was carried out by one reviewer and checked by a second.

Where more than one meta-analytic review was available, we prioritised the one with the higher AMSTAR-2 score. In the case of a tie, the review with the most recent search date was prioritised. However, in some cases we also drew on other reviews in the category, for example if the specification of the meta-analyses was better aligned to the purposes of the toolkit. We also utilised other reviews for cost and implementation data (see below).

We extracted effect sizes and confidence intervals as reported in the reviews. All outcomes were included, if the meta-analysis included more than two studies. For the purposes of the summary findings, outcomes were categorised into six broad types as set out in Table 1 (for reasons of clarity, a few outcome types were not included in the summary).

At this stage we refined the criteria further and excluded the following topics:

- a. Reviews where no outcomes in our categorisation (Table 1) were reported;
- b. Reviews on topics which were carried out entirely in non-healthcare settings and with non-healthcare staff, and where the review team judged there were serious barriers to transferability to healthcare settings, or on purely surgical or pharmacological interventions.

Supplementary searching and data extraction

For cost and implementation data, we initially looked for data within the included impact reviews, and then in the other studies located by our searches. In many cases we needed to supplement these with informal searches of other sources, such as Google Scholar and citation chasing from included studies. For implementation data, we drew on a range of relevant data as appropriate and available, including qualitative research and/or moderator or subgroup analyses of the effectiveness data. For both implementation and costs we prioritised systematic reviews, but also included data from primary studies where we could not locate relevant reviews. Data synthesis was informal, with a focus on drawing out key messages relevant to implementation.

Deriving summary scores

Our rules for deriving summary scores are based on the Youth Endowment Fund (YEF) toolkit on preventing youth violence (<u>https://youthendowmentfund.org.uk/toolkit/</u>). As this toolkit covers a broader range of outcomes than the YEF toolkit, and hence in many cases multiple analyses were reported within a single intervention category, we made some modifications to their

process to clarify how these were handled. Impact ratings, quality ratings and review sizes were only assessed where there was a meta-analysis reporting standardised mean difference or equivalent.

For the impact summary, we initially coded each effect size reported in the reviews as low, moderate or high as follows:

Standardised mean difference (d) / Hedges' g	Categories
d < 0	Harmful
0 ≤ d < 0.35	Low (small)
0.35 ≤ d < 0.65	Moderate
d ≥ 0.65	High (large)

Where effects were not statistically significant at p<0.05 in review authors' analyses, we coded the effect size as 'no significant effect' and did not apply a category.

Where effect sizes were reported as odds ratios (OR), we converted these to standardised mean differences using $d = \ln(OR) \frac{\sqrt{3}}{\pi}$ (Borenstein et al. 2009).

To produce the impact summary using these categories, we applied the following rules:

- Where analyses are reported separately for RCTs and nRCTs, use the analysis of RCTs;
- Where analyses are reported before and after removing outliers, use the former;
- Where analyses are reported for multiple time points for a single outcome, use the earliest for each outcome;
- Where analyses are reported for multiple outcomes within a category, then calculate the median result based on the categories of effect. For this analysis, combine low and no change, so that there are three categories (low + none, moderate, high). Where the median is between categories, round down.

For the evidence quality rating, the AMSTAR-2 rating was used:

- Not rated: 0
- Critically low: 1
- Low: 2
- Moderate: 3
- High: 4

For the review size summary, we categorised the number of studies in the meta-analysis reporting relevant outcomes (if there was more than one such meta-analysis, the studies were pooled):

- 1-2 studies: 1
- 3-4 studies: 2
- 5-7 studies: 3
- 8-11 studies: 4
- 12 or more studies: 5

For the cost rating, we located data on cost per participant where available, and categorised as follows:

- <£500: £
- £500-£1500: ££
- >£1500: £££

Where cost data were reported separately for distinct interventions, we calculated the median across reported interventions (excluding inactive control groups).

The 'how trustworthy is the evidence' sections reflect a combination of the AMSTAR-2 rating of the review and the number of studies, as below:
